- 3. After depositing Bank Draft, the photocopies of the documents regarding proof of Age, Qualification, Experience, Category (as applicable) shall be checked/ Verified from the originals.
- a) Age Limit: 35 Years maximum (as on 01.07.2024)
- b) For **SC/ ST** category candidates, self-attested copy of certificate from appropriate authority in the rank of D.M. Collector/ SDM/ Tehsildar, with legible seal should be submitted.
- c) For OBC (NCL) category candidates, self-attested copy of certificate from appropriate authority in the rank of D.M. Collector/ SDM/ Tehsildar, with legible seal should be submitted. The certificate should be issued after 31.03.2023.
- d) For EWS category candidates, self-attested copy of certificate from appropriate authority in the rank of D.M. Collector/ SDM/ Tehsildar, with legible seal should be submitted. The certificate should be issued after 31.03.2023.
- e) For candidates belonging to **Rural Category**, the certificate must be given in prescribed form generated from NSI website.
- f) For candidates belonging to Defence Category, they are required to submit the self-attested copy of certificates from Secretary, KendriyaSainik Board, Delhi/ Secretary, Rajya/ ZilaSainik Board/ Office In-charge, Records Office/ First Class Stipendiary Magistrate.
- g) For candidates belonging to Physically Challenged, they are required to submit, the selfattested copy of certificate on the letter head duly signed by the Chief Medical Officer of a district hospital with seal.
- 4. The documents shall be verified only after depositing the Bank Drafts.
- 5. The candidates, those who are not having the eligible qualification for the admission may note that the deposited fee particularly in Government Account is not refundable.
- 6. The list of candidate selected for admission shall be declared at 05.00 PM on the same date.
