

In addition to the above, the Committee may co-opt one/two member(s) [expert] at any time as per the requirement.

2. The term of office of the Members of the Advisory Board shall be two years from the date of reconstitution of the Board.
3. The meeting of the Advisory Board shall preferably be conducted twice in a year i.e. one meeting in every six months.
4. The Advisory Board of NSI, Kanpur would advise on important matters relating to Teaching, Research and Advisory/ Extension and Applied Research on sugar factory operational problems with a view to strengthen the Institute in carrying out its core activities.
5. The traveling allowance/ daily allowance of the official members of the Board will be met, as usual, from the same source from which their salaries are paid. The traveling allowance/daily allowance of the non-official members will be regulated at par with Group-A officers (Level-I I) of the Government of India and paid by the National Sugar Institute, Kanpur.
6. The expenditure on this account will be met from within the sanctioned budget grant of the National Sugar Institute, Kanpur in the year in which it is incurred.
7. The other terms and condition of the Advisory Board will be as indicated at **Annexure-I**.
