- (ii) five years working experience in sugar factory or distillery or other related industrial units or five years teaching experience at degree level in Organic chemistry.

- Note 2.- Departmental Assistant Professor (Organic Chemistry) with ten years' regular service in Level- 11 (Rs. 67,700-2,08,700) in the pay matrix shall also be considered along-with deputationists.
