The post of Security Inspector is to be filled up by Short term contract/Deputation (including short term contact) amongst candidates Officials of the Central Government fulfilling the following:-

Short term contract:-

Retired army personnel of the rank of Junior Commissioned Officer or equivalent in the defence services or para-military forces.

Deputation (ISTC):

Officers of the rank of Assistant Sub-Inspector of Police in the State or Central Police organisations with eight years service in the grade. (Period of deputation shall ordinarily not exceed three years).

The maximum age limit for appointment by deputation shall be 'not' exceeding 56 years' as on the closing date of receipt of applications.

Note:- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay commission has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said pay Commission except where there has been merger of more than one per-revised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post or posts for which that grade pay or pay scale is the normal replacement grade without any up-gradation.

The place of posting will be National Sugar Institute, Kanpur (Uttar Pradesh) but libel to be posted anywhere in India.
