### THEME

Effluent Treatment Plant (ETP) now a days is considered as a gate way of sugar & distillery units and a controlling station to decide the operation of sugar & distillery units in view to comply the environmental norms. Efficient operation of ETP has become a need of hour which also otherwise reflects the status of fresh water consumption through three R's (reduce, reuse and recycle). Although many sugar & distillery units have upgraded their ETP system as per the guidelines of CPCB and also might have achieved the notified bench marks of CPCB but this is not the end of our journey until all the sugar & distillery units will comply the notified norms on sustainable basis.
