

THREE DAYS TRAINING PROGRAMMES ON ETP OPERATION AND LABORATORY ANALYSIS

OBJECTIVE

Sugar factories situated in river Ganga Basin are directed for strict compliance of CPCB norms notified for sugar factories to protect environment. As per the CPCB norms, the generation of effluent has been limited to the order of 200 liter/ton of cane crushed. The effluent needs to be treated for its safe disposal on land and /or in water streams as per the prescribed norms.

In view of feedback received from sugar factories in respect of ETP operation and laboratory analysis of operating parameters, factories desired that National Sugar Institute, Kanpur may conduct a training programme on ETP operation and laboratory analysis for their operating and supervisory staff.

Thus, a three days non residential training programme is being organized in TWO phases at National Sugar Institute Kanpur for operating/ supervisory staff of the factories to provide training on efficient operation of ETP, daily analysis and recording of performance parameters, maintaining of log books etc.
