G.S.R. 145 :—In exercise of powers conferred by the proviso to article 309 of the Constitution, the President hereby, makes the following rules further to amend the National Sugar Institute, Kanpur (Group 'A' and Group 'B' posts) Recruitment Rules 1964, namely:—

1. (i) These rules may be called the National Sugar Institute, Kanpur (Group 'A' and Group 'B' posts) Recruitment (Amendment) Rules, 1985;

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the National Sugar Institute, Kanpur (Group 'A' and Group 'B' posts) Recruitment Rules, 1964 for the entries against the post at Serial No. 32 relating to the post of Statistician, the following shall be substituted, namely:—

			Not exceeding 30 years. (Relaxable for Government servants upto 5 years in accordance with the instructions or orders issued by the Central Government.) Note : The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates in India (other than those in Andaman and Nicobar Islands and Lakshadweep).

Essential :

Note 1 Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

Note 2 The qualifications regarding experience is/are relaxable at the discretion of the Union Public Service Commission in the case of candidates belonging to Scheduled Castes and Scheduled Tribes if, at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

Promotion/Transfer on deputation :

(1) Officers under the Central Government:

(a) (i) Holding analogous posts; or (ii) with 3 years' service in posts in the scale of Rs. 550-900 or equivalent; or (iii) with 8 years' service in posts in the scale of Rs. 425-700/800 or equivalent; and

(b) Possessing the educational qualifications and experience prescribed for direct recruits under column 7.

(2) The departmental Statistical Assistant possessing at least Degree with Mathematics/Economics/Operation Research/Statistics/Commerce as a subject of recognised University or equivalent and 8 years' regular service in the grade will also be considered and in case he is selected for appointment to the post the same shall be deemed to have been filled by promotion.

The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

(Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same organisation/department shall not ordinarily exceed 3 years.)
